ELIGIBILITY

Entries are open to all amateur golfers (male and female) who are at least 21 years of age as of the tournament date, and are affiliated with a WSGA member club. Contestants must be 2008 WSGA associate members which includes having a 2008 WSGA/USGA handicap index. The competition will be comprised of partners (two players) who need not belong to the same club. A team may consist of two men, a man and a woman, or two women. The maximum handicap index allowed any contestant will be 36.4 for men and 40.4 for women. Handicaps exceeding the maximum shall be reduced to the maximum allowed. The date of the most current handicap index to be used for the tournament will be established by the Tournament Committee.

FORMAT

Competition will be 18 holes of partners net stroke play. The winning team will be determined by adding each player's 18-hole net score plus the 18-hole net bestball score of the team. All handicap indexes will be adjusted according to the slope rating of the course. Men will use the regular tees and women will use the forward tees. Women will receive extra strokes dependent on the course set-up, not to exceed two strokes, plus or minus the difference between the respective course ratings. Playoffs required to determine the champion will take place immediately on a hole-by-hole basis, combining the individual net scores, with strokes being given in accordance with the scorecard allocation. All other ties will be determined by a computer selected scorecard playoff method. Approximately seven teams from each of the eight Net Partners events will qualify for the Net Partners Championship (Sept. 12). Players on teams that qualify for the championship must have a minimum of five scores played and posted by Sept. 4 in order to be eligible.

DEADLINE

The field will close at 56 acceptable teams or by 5 p.m. on Monday, Aug. 18, 2008. Late, incomplete or phone entries are not acceptable. Fax entries are acceptable only if using a credit card as method of payment.

The WSGA fax number is (414) 443-0817. Entries will be processed on a first come, first served basis. Players and teams may participate in more than one Net Partners event. If an event is over-subscribed on the deadline date, teams which have already qualified for the Net Partners Championship will be replaced by the next team on the waiting list.

PRACTICE

There will be no official practice round. Call (262) 242-2470 to inquire about scheduling a practice round - at the player's expense. Mequon CC is private and access may be limited.

PAIRINGS AND STARTING TIMES

Pairings will be made by the WSGA and players will be notified of their starting times and places by mail or e-mail and posted on the WSGA Web site (www.wsga.org). The competition will feature a shotgun start at approximately 8 a.m.

CARTS

Motorized carts may be used by contestants. Please indicate on entry if a cart is desired. Also, call (262) 242-2470 prior to the start of the tournament to ensure that a cart has been reserved. Some courses may have limitations on the number of available carts. Players may carry their clubs. Caddies are not allowed.

ENTRY FEE / METHOD OF PAYMENT

Entry fee is \$105 per team. Checks or credit cards are accepted. Entry fee includes lunch for all contestants. Online registration available at www.wsga.org.

PRIZES

Low net teams will receive prizes emblematic of their respective finishing positions. The low seven teams will receive awards.

LOCATION OF CLUB
